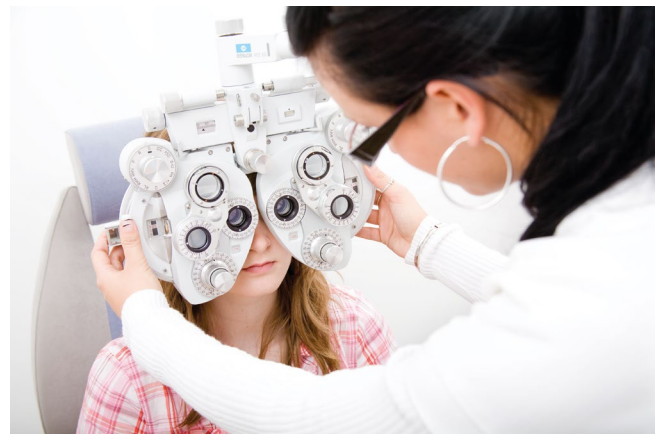

FREQUENTLY ASKED QUESTIONS

What is the purpose of accreditation?

To (1) objectively assess, evaluate, and validate the quality of clinical and non-clinical services; (2) identify areas for improvement; and (3) optimize the quality of services, assuring the complete continuum of care.

How long does the accreditation process take?

The entire accreditation process takes between 6 to 12 months and depends in large part on the progress of the Client's self-assessment, assisted by Temos' unique on-line tools.

For how long is the accreditation valid?

Temos accreditation is valid for three years at which time the re-accreditation process is started.

What are the costs of accreditation with Temos?

The initial costs are a flat fee based on the size of the organization in addition to direct expenses for assessors (travel & for on-site visit). Reasonable annual fees are due at the end of year one and year two of the three-year validity period.

How is the accreditation process started?
