FREQUENTLY ASKED QUESTIONS



What is the purpose of accreditation?

To (1) objectively assess, evaluate, and validate the quality of pharmacy services; (2) identify areas for improvement; and (3) optimize the quality of services, assuring the complete continuum of care.

How long does the accreditation process take?

The entire accreditation process takes between 6 to 12 months, depending on the timeliness of the self-assessment.

For how long is the accreditation valid?

Temos accreditation is valid for three years.

What are the costs of accreditation with Temos?

The initial costs are a flat fee, based on the size of the organization, plus direct expenses for assessors (travel & on-site visit). Annual fees are due at the end of year one and year two of the three-year validity period.

How is the accreditation process started?

Call or email us today. You may also visit the Temos website. You will be assigned a private, secure user name and password to access the Temos Information Chart (TIC). Complete the TIC to receive your free estimate of costs and expenses to invest in your organization.
